RE: Request for Supervised Release Residence Report- [REDACTED] Terry Rd, Hartford, WI 53095

Christina Johnson;

I have reviewed the Department of Health Services' request to place [REDACTED] Terry Rd in the Township of Erin, Washington County, WI and strongly oppose the placement due to the follow:

Chapter 980.08(4)(f) prohibits the placement of [REDACTED] at a property that would be less than 1500 feet away from another property where a minor child primarily resides.

The property of [REDACTED] Kilkenny Ct. is 1322 feet away from the property of [REDACTED] Terry Rd. A minor male primarily resides at that address full time with both of his biological parents.

Additionally there is a [REDACTED] old child that partially resides at [REDACTED] Terry Rd. The child is present at the home on weekends. This home is 1354 feet away from [REDACTED] Terry Rd, the proposed placement site of [REDACTED]

There are further considerations to be made when deciding if [REDACTED] should be placed at this location. Residing at [REDACTED] Kilkenny Ct. is a [REDACTED] year old, [REDACTED] year old and [REDACTED] month old. This home is just outside the exclusion area but as the area is a rural setting the offender will have straight line of sight to watch and monitor these minor children.

Additionally there is a public elementary school ½ mile south of [REDACTED] Terry Rd. The school has a daily student population of 380 children ranging from k4 to 8th grade age students. The school also host after hour events including youth sports, Boy Scout, Girl Scouts, a religious good news club, and a before and after school daycare with children ranging from 4 years old to 13 years old. The school is also going to be used as a [REDACTED] during an upcoming national event.

Again this is just outside the exclusion area but as the area is a rural setting the offender will have straight line of sight to watch and monitor these minor children and activities.

Lastly there is a large public outdoor sports area and public park located next to the Erin Town Hall, about a ½ mile east of [REDACTED] Terry Rd. This area consists of several soccer, football, baseball, and basketball fields and courts. Also in the park are several nature walking trails which pass through fields and wooded areas. During spring, summer, and fall the park is used daily by youth sports organizations. Residents of the Town of Erin regularly use the park and walking trails throughout the entire year. The park is just outside the exclusion area but as the area is a rural setting the offender will have straight line of sight to watch and monitor the park and youth sport activities.

Placing [REDACTED] at [REDACTED] Terry Rd, in the Township of Erin, Washington County, WI does not meet the requirements of WI Stats. 980.08(4)(f). [REDACTED] placement at the address would also be a danger to the public, the students at the public school, the users of the public park and sports area, and to the users of the school grounds during after hours activities.
